# **SYLLABUS**



**SPORTELLO UNICO PER L'IMMIGRAZIONE (S.U.I.):** One-stop shop placed within the competent Territorial Office of the Government (Prefecture)

#### **QUESTURA:** territorially Police Headquarter





**ITALIAN DIPLOMATIC-CONSULAR AUTHORITY:** belongs to the Ministry of Foreign Affairs and International Cooperation (MAECI)

# **1** Criteria for requesting family reunification

### 1. Relationship

**Family members** for whom family reunification can be requested:

- spouse not legally separated and not younger than 18 years of age
- minor children, including those of the spouse or born out of marriage, who are unmarried, provided that the other parent, if any, has given his or her consent
- dependent adult children, if for objective reasons they cannot provide for their indispensable living needs due to their state of health resulting in total disability
- dependent parents, if they have no other children in their country of origin or provenance, or parents aged 65 and over, if their other children are unable to provide for their subsistence due to perdocumented, serious health reasons.

### 2. Income

Commensurate with the number of people to be reunited ("[...] Not less than the annual amount of the social allowance increased by half the amount of the social allowance for each family member to be reunited")

### 3. Accomodation

Statement of how many people can live in the housing and that the housing meets the hygienic and sanitary requirements





# 2 The procedure to apply to family reunification

- 1. Telematic application at the One-stop shop for the submission of documentation on the possession of the requirements about income and housing made by the third-country national residing in Italy who holds a valid residence card or residence permit of not less than one year issued for the following reasons: subordinate work, self-employment, asylum, study, religious reasons, family reasons.
- 2. Once the **authorization has been granted** by the One-stop shop, the family member submits an **application** for an **entry visa** to Italy at the Italian diplomatic-consular authority.
- 3. Once the Entry Visa is obtained, the reunited family member must request an appointment to complete the first entry procedure at the One-stop shop within 8 days of their entry into Italy.
- **4. Presentation of the receipt** from the One-stop shop to the competent **Police Headquarter** to collect the First Residence Permit for the family member.





# **3** (Government) institutions involved during the application

- **Municipal office:** responsible for issuing the housing eligibility certificate, which is a prerequisite for applying for family reunification;
- **Sportello Unico per l'Immigrazione (S.U.I.)**: responsible for issuing family reunification permission following the submission of the required documents;
- **Italian diplomatic-consular authority:** responsible for issuing the entry visa to Italy following the presentation of the authorization (issued by the S.U.I.) and the certification attesting to the family relationship;
- **Questura:** responsible for issuing the First Residence Permit for Family Reunification following the presentation of a receipt from the S.U.I.

# **4** Recent developments regarding family reunification (2/3)

# **4** Recent developments regarding family reunification (3/3)

#### Key points for integration after reunification:

- Italy faces challenges in integrating women spouses of economic migrants into the labor market
- High percentages of inactivity among this group, estimated between 80% and 90%
- Challenges arise from traditional gender roles in communities of origin (e.g., Bangladesh, Pakistan, Egypt)
- Complexity of local services hinders effective outreach and support for these women
